CORONAVIRUS DISEASE (COVID-19) ADVISORY WARNING STAY SAFE, STAY HEALTHY, STAY HOME

The Contra Costa County Health Department has ordered individuals in Contra Costa County to "shelter in place". The California Department of Public Health issued its "Mass Gatherings Guidance on Novel Coronavirus or COVID-19" followed by a recommendation that certain gatherings in California be postponed or canceled.
