The Concord City Council met in a regular meeting in the City Council Conference Room located in Wing A at 1950 Parkside Drive at 5:00 p.m. on Tuesday, March 3, 2015, with Mayor Grayson presiding. All Councilmembers were present. The meeting was recessed and immediately reconvened in a closed session to confer with Legal Counsel pursuant to Government Code Section 54956.9(a) pending litigation/administrative proceeding entitled: *In the Matter of the Arbitration of Ameet Patel v. City of Concord*, No. ARB 14-0067.

The meeting adjourned at 5:25 p.m. to reconvene in regular session in the Council Chamber.

APPROVAL OF MINUTES

Motion was made by Hoffmeister and seconded by Helix to approve the minutes for the meeting of February 3, 2015. Motion passed by unanimous vote of the Council.

APPOINTMENTS TO THE BICYCLE, PEDESTRIAN AND SAFE ROUTES TO TRANSIT PROJECT ADVISORY COMMITTEE

Motion was made by Helix and seconded by Grayson to appoint Sergio Huerta and Claire Linder as Committee Members and Randy Marsh and Kenji Yamada as alternate members to the Bicycle, Pedestrian and Safe Routes to Transit Project Advisory Committee. Motion passed by unanimous vote of the Council.

LEASE FINANCING PLAN IN CONNECTION WITH THE FINANCING OF STREET AND OTHER INFRASTRUCTURE IMPROVEMENTS IN THE CITY

Director of Finance Karan Reid gave a report, referring to her memorandum dated March 3, 2015, and reporting that staff was recommending authorization of lease financing documents in connection with the financing of street and other infrastructure improvements in the City and approving related documents and actions.

Following questions by the Council, Mayor Grayson opened a public comment period and receiving no public comment, closed the public comment period.

Following comments by the Council, a motion was made by Helix and seconded by Birsan to adopt Resolution No. 15-14 entitled, "A RESOLUTION APPROVING THE FORM AND AUTHORIZING THE EXECUTION OF CERTAIN LEASE FINANCING DOCUMENTS IN CONNECTION WITH THE FINANCING OF STREET AND OTHER INFRASTRUCTURE IMPROVEMENTS IN THE CITY; AND AUTHORIZING AND DIRECTING CERTAIN ACTIONS WITH RESPECT THERETO." Motion passed by unanimous vote of the Council.

A Motion was made by Helix and seconded by Birsan to adopt Resolution No. 15-1 entitled, "A RESOLUTION OF THE CITY OF CONCORD JOINT POWERS FINANCING AUTHORITY APPROVING THE FORM AND AUTHORIZING THE EXECUTION OF TERMINATION AGREEMENT RELATED TO A PREVIOUSLY FINANCED FACILITY AND

AUTHORIZING AND DIRECTING CERTAIN ACTIONS WITH RESPECT THERETO." Motion passed by unanimous vote of the Authority.
