BICYCLE AND PEDESTRIAN ADVISORY COMMITTEE

The Bicycle and Pedestrian Advisory Committee was created by the City Council on January 10, 2017, with the adoption of Resolution No. 17-3.

The role of the Bicycle and Pedestrian Advisory Committee (BPAC) is to review transportation capital projects including roadway, pedestrian and bicycle improvements and provide input to staff on Complete Streets features and for conformity with the City's Bicycle, Pedestrian and Safe Routes to Transit Plan, adopted in September 2016 (Plan); review related grant applications; annually review the City's progress on Plan implementation; and, review and provide input on programs or policies related to implementation of the Bicycle, Pedestrian and Safe Routes to Transit Plan as requested by staff or the City Council.

The BPAC consists of five (5) members serving four (4) year terms. Initial terms will be staggered with three (3) appointments serving four (4) years and two (2) appointments serving two (2) years. Members must be Concord residents and be enthusiastic about Complete Streets, cycling and other alternative modes of transportation.

The BPAC meets Quarterly and more frequently as needed.

BOARD OF APPEALS

The five-member and two-alternate Board of Appeals meets as needed to interpret State law and the California Building Standards Code pertaining to construction standards for the City. They make a determination of suitable alternate materials and methods of construction and hear appeals of orders, decisions, and determinations made by the City's Chief Building Official. Decisions of the Board are final and may not be appealed to the City Council. The Board of Appeals consists of members who are qualified by experience and training to pass on matters pertaining to the City of Concord Construction Code and are not employees of the City. Appointees must be qualified in and specifically knowledgeable in the City of Concord Construction Code and applicable local ordinances.

The City's Conflict of Interest Code requires members to disclose interests in investments, real property, and income derived within the City of Concord or from sources doing business within the City of Concord. Filings are required within 30 days of assuming office and on an annual basis. Meetings are held on an infrequent basis.

CENTRAL CONTRA COSTA TRANSIT AUTHORITY ADVISORY COMMITTEE

The Central Contra Costa Transit Authority Advisory Committee shall be comprised of eleven (11) members from Central Contra Costa County. Each member jurisdiction will be requested to recommend one member from that jurisdiction for appointment by the CCCTA Board of Directors. Each member jurisdiction may also recommend an alternate member from that jurisdiction for appointment by the CCCTA Board of Directors. Representative should be active in community participation and involvement, should reside in the appointed community and should be a current or former user of fixed-route and/or paratransit service, or an advocate for transit users in their communities. The primary purpose of the Advisory Committee will be to review, analyze and advise the County Connection Board of Directors on issues and policies relating to fixed-route and paratransit service. The Advisory Committee will be asked to consider and make recommendations on finance and planning documents that include but are not limited to the following: CCCTA Ten Year Short Range Transit Plan, annual operating and capital budget, annual marketing plan, other issues such as operations, scheduling, administration, finance, and legislation.

Members are required to identify housing, neighborhood and social needs within the community and review funding requests, advise the City Council on the allocation of General Fund monies for human services and the expenditure of Federal Community Development Block Grant monies for programs and projects, and monitor the performance of funded programs. All members must be residents of Concord or of Concord's sphere of influence who hold no other municipal office in the City of Concord and shall be representative of the general public and the religious, racial, age, sex, disabled and ethnic groups in the City of Concord.

The City's Conflict of Interest Code requires the Community Services Commission members to disclose interests in investments, real property, and income derived within the City of Concord or from sources doing business within the City of Concord. Filings are required within 30 days of assuming office and on an annual basis.

CONCORD NAVAL WEAPONS STATION REUSE PROJECT COMMUNITY ADVISORY COMMITTEE

At its meeting on July 12, 2016, the Council adopted LRA Resolution No. 16-14 to establish a Community Advisory Committee (CAC) for the purpose of having robust community outreach and engagement in the Specific Plan process for the Phase 1 Development of the Concord Naval Weapons Station.

The CAC shall consist of 11 members and 3 alternates appointed by the City Council. To ensure the desired balanced representation on the CAC, member selection criteria shall include: diversity and breadth of interest, broad representation of the community, geographic balance, familiarity with the adopted Reuse Area Plan, understanding of the CAC function and role; and commitment to Reuse Project goals and guiding principles.

All CAC members shall be Concord residents.

The CAC shall apply the Reuse Project Goals and Guiding Principles, adopted Reuse Area Plan policies and accepted Term Sheet provisions in evaluating and commenting on potential Specific Plan alternatives or issues. The CAC shall also serve as a communication link between the Reuse Project and the community-at-large by assisting in targeting outreach to neighborhoods and interest groups, and promoting participation at workshops and public meetings.

All members of the CAC will be subject to State and City Conflict of Interest laws and are required to complete a Statement of Economic Interest (FPPC Form 700) at the time of appointment, annually, and at the end of the term of service. These documents will be made available to the public upon request.

CONCORD PAVILION COMMUNITY OUTREACH COMMITTEE

In conjunction with all of the above, the Aviation Advisory Committee shall provide a forum for the Manager of Airports regarding operational and/or policy matters at and around the airport.

The Contra Costa Transportation Authority has requested that each city and the County appoint a citizen to serve on the Authority's Citizen Advisory Committee. COUNTY IRON HORSE TRAIL COMMITTEE

The Iron Horse Corridor Management Program Advisory Committee includes seats for one representative from each jurisdiction or unincorporated community along the corridor (Alamo, City of Concord, City of San Ramon, Town of Danville, City of Walnut Creek, and City of Pleasant Hill); a District III seat; a District IV seat; and a seat for the East Bay Regional Park District. The Committee was authorized by the Board of Supervisors on July 22, 1997, to assist Contra Costa County in developing a management program for the former Southern Pacific Railroad right-of-way known as the Iron Horse Corridor. The Corridor extends approximately 18 miles from near Mayette Avenue in Concord to the Alameda County line. In 2000, the Board of Supervisors expanded the Advisory Committee's role to continue to work on implementing and monitoring the Landscape Element of the Management Program and to assist in completion of the Joint Use Criteria and Standards, Public Information and Finance Elements of the Management Program.

DESIGN REVIEW BOARD

The Design Review Board is composed of five members: three (3) design professionals may be nonresidents of Concord, e.g., architects, landscape architects, urban designers, building designers, at least one of whom shall be a professional licensed architect, and one (1) public member, each serving a four-year term, and one (1) member of the city Planning Commission. The public member shall be a resident of Concord with previous experience or training in design concepts. Example of duties would include; reviews the design of each improvement for which a building permit, certificate, or other approval is required and any matter referred to the Board by the City Council, Planning Commission, Zoning Administrator, or Planning Manager, and/or staff. The City's Conflict of Interest Code requires Design Review Board members to disclose interests in investments, real property, and income derived within the City of Concord or from sources doing business within the City of Concord. Filings are required within 10 days of assuming office and on an annual basis. Design Review Board members receive \$50 per regular or special meetings for a maximum of six meetings per month. JOHN MUIR/MT. DIABLO COMMUNITY HEALTH FUND BOARD

The City Council sitting as the Concord/Pleasant Hill Health Care District Board appoints three representatives on the John Muir/Mt. Diablo Community Health Fund Board (CHF). CHF Board members are responsible for governing the Community Health Fund, which is a tax-exempt 501(c)3, non-profit corporation and supporting organization to John Muir Health. The primary governing responsibilities include vetting, awarding and monitoring grants, establishing grant making and operating policies, approving annual operating budgets, annually evaluating the Executive Director, and annually electing the officers for the Board of Directors. The

Board members are not compensated for their service on the Board and must operate under the CHF bylaws. Board Member selection criteria for the three members appointed by the City of Concord are as follows: a)All members shall be at least 18 years of age and reside within the City of Concord or Concord's Sphere of Influence; b)Members may be members of the elected Concord City Council, but limited to only two members of the City Council; c)Members may not be employees of the City of Concord, nor may they be a vendor, contract or consultant with active contracts or agreements with the City of Concord; d)Members may be a member of one of Concord's Boards and Commissions, but may not be currently serving as a member of the Concord/Pleasant Hill Health Care District Grant Committee; e)The City Council serving as the Concord/Pleasant Hill Health Care District Board may elected at any public meeting to appoint up to two of its members to serve on the CHF Board prior to opening a recruitment for the remaining members.

MEASURE Q COMMITTEE

The Measure Q Oversight Committee shall consist of five members; at least one representing the business community, at least three residents of the City of Concord, and the fifth member from either category. Members will serve four year terms.

The Measure Q Oversight Committee shall fulfill two areas of responsibility of each of the years that the Measure Q half-cent use and transaction tax is collected: 1. Review the City"s annual audit report which will include the Measure Q tax revenue and expenditures; 2. Provide recommendations to the City Council on the use of Measure Q revenue. The Committee shall produce a report that records the results of its review of the City"s audit and its recommendations for expenditure of the revenue generated from the tax. The report shall be presented to the Council at a public meeting and shall be a public record.

The City"s Conflict of Interest Code requires the Measure Q Oversight Committee members to disclose interests in investments, real property, and income derived within the City of Concord or from sources doing business within the City of Concord. Filings are required within 30 days of assuming office and on an annual basis. The Committee will be active from February through June each year. The Committee will meet between three and six times during each budget cycle.

The Commission advises the City Council on matters related to public parks, open space, recreation, and youth; reviews and recommends Council action to develop, modify, and/or improve City parks; promotes recreation and park programs, assesses park and recreation needs, and recommends capital improvement projects and fees. The City's Conflict of Interest Code requires the Parks, Recreation and Open Space Commission members

to disclose interests in investments, real property, and income derived within the City of Concord or from sources doing business within the City of Concord. Filings are required within 30 days of assuming office and on an annual basis.

PLANNING COMMISSION

The Planning Commission is made up of five (5) members serving four (4) year terms. Members must be residents of Concord who hold no other municipal office in the City of Concord. The Planning Commission develops and maintains the General Plan of the Concord Planning Area; develops specific plans as may be necessary; makes recommendations to the City Council regarding proposed General Plan amendments and municipal code modifications, reviews planned district developments, tentative subdivision maps, and use permit applications. The State of California Political Reform Act requires Planning Commission members to disclose interests in investments, real property, and income derived within the City of Concord or from sources doing business within the City of Concord. Filings are required within 10 days of assuming office and on an annual basis. Planning Commission members receive \$50 per regular or special meetings for a maximum of six meetings per month. (Resolution No. 85-9)

RESIDENTIAL RENT REVIEW PANEL

The Residential Rent Review Panel's role will be to review case material submitted by landlords and tenants where resolution has not been achieved through mediation and render a non-binding decision in a public

hearing.

All members of the Panel must be Concord residents. The Panel will be made up of three members and three alternates, all appointed to a term of four years:

- One member and one alternate must be a landlord of a multi-family complex of three or more units, with priority to landlords that own property within the City of Concord
- One member and one alternate must be a tenant of a multi-family complex of three or more units
- One member and one alternate must be a neutral party, for example, a single family homeowner

The Panel will have the following duties and responsibilities:

In the event an agreement is not reached during rent review mediation, either party may request a hearing before the Rent Review Panel within 10 calendar days after notice of completion of the conciliation and mediation process has been issued.

The hearing will be scheduled within 30 calendar days of the request for consideration and will be a public hearing. City staff will prepare a short staff report for the Panel, presenting the facts of the case but with no recommendation. Staff from both ECHO and the City will attend the hearing, but the hearing itself would be run by the Panel. At the hearing, the landlord and tenant will each have an opportunity to make their case. The Panel will review documents in the record, call witnesses who may be present, and make a recommendation to resolve the dispute. The Ordinance provides an illustrative list of the types of factors the Panel may consider in reaching their conclusion, including the past history of rent increases, the landlord's operating and capital costs, existing market rents for similar units, and reductions in service to the tenant.

The Panel's determination will be formalized by staff in a brief report, and mailed to the landlord and tenant within seven calendar days of the hearing. Although the determination is non-binding, the landlord and tenant would have the option of formalizing the agreement in a standard form to be signed by both parties.
