She works for the Contra Costa Adult Continuum of Services and “their role is to provide adults with food, safe shelter, and referrals to needed support services as well as a stepping stone toward self-sufficiency.” There are two emergency shelters for Adults one in Concord and Richmond. They both offer meals, laundry facilities, telephone, mail, advocacy and case management. Monahan shared they are seeing more elderly in the shelters. Commissioner Lee shared with Monahan the Be A Santa to A Senior service project and the Commission on Aging would like to work with her on providing needed items to the clients at the shelter. Commissioners thanked Monahan for attending the meeting and look forward to working with her.*
