**SCHEDULE OF BUSINESS LICENSE TAXES**

This form is to be used to determine the appropriate business license tax to be paid for your class of business. Please complete your Business License Application and return it along with your check made payable to the City of Concord, 1950 Parkside Drive, M/S 06, Concord, California 94519-2578. **A twenty-two dollar (\$22.00) application fee will be charged in addition to the tax calculated from the schedule.**  
**A twenty-two dollar (\$22.00) administrative fee will be charged for all license renewals in addition to the taxes due.**

**NOTE: California Special Disabilities (CASp) Fee is \$4.00 beginning January 1, 2018 through 2023.**

**CLASS CODE 0 – GROSS RECEIPTS SCHEDULE – Retail/Wholesale (Minimum - \$25)**

If you were in business for the entire preceding 12 month period, current year tax is to be based on the prior year's gross receipts. Gross receipts include the total amounts actually received or receivable from sales or service. Included in gross receipts shall be all receipts, cash, credits and property of any kind. If last year was your first full year of operation, a special area is provided on the back of the renewal affidavit card for adjusting taxes paid on prior year's estimates.
